**TENDER FOR SUPPLY OF**  
**COTTON, POLYESTER COTTON (Grey & Dyed), POLYESTER VISCOSE,**  
**POLYESTER FILAMENT AND DYED ART SILK YARN**

The Karnataka Handloom Development Corporation Limited (A Government of Karnataka Enterprise), Bangalore, invites tenders from yarn manufacturers for supply of Grey Cotton, Polyester Cotton (Grey & Dyed), Polyester Viscose, Polyester Filament and Dyed Art Silk Yarn in different varieties as per the specifications indicated at Annexure "A" & "B" required for a period of three months.

Following are the terms & conditions:-

**A. METHOD OF SUBMISSION OF TENDER:-**

- i) Tenders shall be submitted separately for Grey Cotton, Polyester Cotton, Polyester Viscose /Polyester Filament and Dyed Art Silk Yarn varieties in the format enclosed at Annexure "C" , "D" , " E " , " F1" & " F2".
- ii) Tenders shall be submitted in two parts in two different sealed covers as under:-

**a) TECHNICAL BID:-**

Sealed cover containing Earnest Money Deposit of Rs.50,000.00 should be submitted compulsorily as per Annexure "C" along with Yarn Test Reports of Textiles Committee OR Reputed Testing Laboratories for all technical parameters as indicated at Annexure "A & B" shall be submitted with Technical Bid or TEN Sample Cones [even in case of Hanks also] & TWO Sample cones incase of Filament Yarn and Art silk, each CONE of 100 gms should be submitted compulsorily as per Annexure "C" & "D".

**b) PRICE BID:-**

As per Annexure "E " , "F1" & " F2" in separate sealed covers.

**01. TECHNICAL BID - COVER 1:-**

- a) To be submitted in sealed cover superscribed as "EARNEST MONEY DEPOSIT & TECHNICAL BID Tender No.KHDC:MD: M(PUR):2009-10/2182 dated: 23.10.2009 for supply of Grey Cotton, Polyester Cotton (Grey&Dyed), Polyester Viscose, Polyester Filament and Dyed Art Silk Yarn **due on 23.11.2009** upto 11.00 A.M together with a Demand Draft for Rs.50,000.00 in favour of `THE KARNATAKA HANDLOOM DEVELOPMENT CORPORATION LIMITED`, payable at Bangalore. No other mode of payment of Earnest Money will be accepted.
- b) Earnest Money Deposit submitted by the tenderer /s will not carry any interest.
- c) Earnest Money Deposit of unsuccessful tenderer /s shall be returned within 30 days from the date of finalisation of the tender.
- d) Earnest Money Deposit of the successful tenderer /s shall be returned by the Corporation only after satisfactory completion of the supplies in respect of the orders placed under tender.
- e) Exemption from submission of Earnest Money Deposit will be considered wherever the Organization/Tenderer is exempted from payment of Earnest Money Deposit by virtue of special notification by the Govt. The copy of such notification issued in favour of the Organization/Tenderer should be enclosed along with the Technical Bid, failing which the tender will be disqualified.
- f) In case of Cotton, Polyester Blended & filament yarn, Yarn Test Reports from reputed Test Houses OR In-house Testing Laboratories of the tenderer should be submitted for all technical parameters as indicated at Annexure "A & B".
- g) Random samples of yarn will be drawn from each consignment before dispatch from the mills by the KHDC officials of Quality Control Department, and the yarn will be tested for its parameters in reputed testing laboratory of State / Central Government and on the basis of the Quality Test Report, despatch instructions will be given to the Mills. Testing charges for all samples drawn before and after supplies should be borne by the tenderer.
- h) The Corporation has the right to draw samples after the supplies are made and in case any discrepancies noticed regarding quality as per test report OR / at preparatory / weaving stages, the defective quantity of yarn should be replaced with yarn of satisfactory Quality at supplier's cost.
- i) The Technical Bid should be submitted on the Mills letter head indicating the Name and Address of the Tenderers` Head Office, Mills, nearest Branch Office, Varietywise monthly production capacity and monthly delivery schedule.
- j) In the Technical Bid, the cost of the yarn should not be indicated. The tenders shall be submitted in English language only.

**2. PRICE BID (COVER - 2):-**

a) The " PRICE BID " shall be submitted in a sealed cover super scribed as " PRICE BID " for tender No. KHDC : MD : M (PUR) : 2009-10: 2182 dated : 23.10.2009 for supply of Grey Cotton, Polyester Cotton (Grey & Dyed), Polyester Viscose, Polyester Filament and Dyed Art Silk Yarn due on 23.11.2009 at 11.00 A.M in the enclosed Annexure format "E" for Cotton Yarn and Annexure " F1" & " F2" in case of Polyester Blend, Dyed Art Silk & Filament yarn.

b) All the details in the format shall be filled and signed by the Tenderer.

c) The PRICE BID should be accompanied by the supporting documents, if any.

d) Tenderer shall indicate the duties & taxes wherever applicable. While indicating the Duty, if any, and sales tax, percentage of taxes on the basic price shall be indicated. failing which it will be presumed that the rates tendered are Nett, Freight extra, & no claims on this account will be entertained at a future date.

e) The tender will be considered only if submitted as indicated above.

f) The two covers (Technical and Price Bids) should be enclosed in a sealed master cover superscribed as "TENDER FOR SUPPLY OF YARN" and addressed to the Managing Director, The Karnataka Handloom Development Corporation Limited, No.1, Priyadarshini Commercial Complex, Tank Road, Halasur, Bangalore 560 042.

**B. RECEIPT OF TENDERS:-**

01. Tender shall be received by the Corporation at its Bangalore Office on or before 23.11.2009 upto 11.00 A.M and bids received after the due date and time will be summarily rejected. No Telegraphic/Fax tenders will be considered and will be rejected out right.

02. No correspondence will be entertained once the tender has been submitted in response to the tender notice and no additional tender will be accepted.

**C. OPENING & SELECTION OF TENDERS:-**

a) Tenders will be opened by the authorised officials of the Corporation in the presence of tenderers who wishes to be present at 11.30 A.M on 23.11.2009.

b) The envelope carrying the Earnest Money Deposit and Technical Bid of the tenderers who have submitted Earnest Money Deposit earlier would be opened. Bids not accompanied by Earnest Money Deposit even if opened are liable to be rejected. However, the right to accept/reject such tender/s will be at the discretionary powers of the MANAGING DIRECTOR of the Corporation.

c) Samples submitted along with Technical Bid will be sent for Technical evaluation.

d) Orders will be placed on one or more tenderers considering quantity, price and delivery schedule.

e) The Corporation reserves the right to call all the qualified tenderers who have participated in this Tender for Negotiations and finalisation of rates/ quantity commitment and terms for yarn requirements for Three Months and place orders on quarterly basis or as and when felt necessary by the Management.

#### **D. VALIDITY OF THE OFFER AND DELIVERY SCHEDULE:-**

The Tender shall be valid for a minimum period of 120 days from the date of opening the Price Bid. Accepted rates should be firm throughout the contract period i.e. execution of the purchase order in full as per the delivery schedule that will be indicated in the purchase orders to be issued from time to time. The delivery schedule may be postponed or pre-poned with 15 days prior Notice depending upon the requirement of the production units. The Corporation reserves the right to extend the rate validity for different varieties of yarn offered by the tenderer from time to time by mutual consent.

#### **E. TERMS OF SUPPLY AND PENALTIES:-**

1) Orders will be placed on one or more tenderers whose tenders are accepted at the discretion of the Corporation, subject to compliance with the terms & conditions.

2) Supplies should be effected in one truck load at a time and completed as per the delivery schedule mentioned in the purchase order by the Mills.

3) After drawing samples at random from each lot supplied i.e. bulk quantity, yarn will be tested for its Quality parameters as mentioned in the purchase order.

4) Successful tenderer shall supply the yarn as per the schedule mentioned in the purchase order. Failure to supply as per schedule, tenderer will pay liquidated damages at 1/2% per week on the value of such undelivered material till completion of supply. This clause is applicable for all varieties of Polyester Blend yarn only. However, PENALTY CLAUSE shall not be applicable in case of delay in release of payment by KHDC, against previous supplies, by more than 15 days after due date.

5) Part of a week will be treated as full week. For purpose of calculation of liquidated damages, date of receipt of offer letter for quality Inspection and Proforma Invoice together with bale/bag numbers will be taken into account. Details of recovery of liquidated damages will be furnished by Manager-Accounts, The Karnataka Handloom Development Corporation Limited, Bangalore to the concerned supplier along with the payment.

- 6) The Corporation shall have the right to recover any loss that it may sustain consequent to any breach on the part of the tenderer / s to fulfill the terms of contract including failure to supply partially or in full/irregular supplies out of Earnest Money Deposit.
- 7) Successful tenderer before taking bulk production, samples of dyed yarn should be sent for verification and approval (In case of dyed yarn). Only after written approval for each variety of yarn, further bulk production should be undertaken.
- 8) The successful tenderer/s is/are responsible for proper packing/transportation of the yarn to KHDC units in good condition. Packing of Polyester Filament /Polyester Blend yarn should conform to ISI standards.
- 9) The KHDC Ltd., reserves the right to cancel the order OR forfeit the EMD if the supplies are not satisfactory as per the contract.
- 10) The KHDC Ltd., reserves the right to place orders through NHDC Ltd., Bangalore to avail of benefits under "Mill Gate Price" scheme.
- 11) Successful tenderers on receipt of the Purchase Orders shall return a copy of the Purchase Order for having accepted the terms and conditions of supply and payment in respect of purchase orders issued against the tender. Any objections regarding payment shall be raised within 3 months from the final settlement of the bill and no claims thereafter shall be entertained.
- 12) No changes in terms of contract as may be requested by the tenderer/s including rates shall be entertained during the tender contract period.
- 13) Courts at Bangalore alone shall have the jurisdiction in case of any disputes arising between parties thereto either for the enforcement of the contract and/or for any damages on account of breach of any of the terms of this agreement. FORCE MAJEURE conditions shall apply.
- 14) The KHDC Limited reserves the right to accept / negotiate the rates and terms / or reject all or any part of the offer as well as decrease or increase the quantity of purchase order without assigning any reasons thereof. The KHDC Limited shall not give any guarantee regarding the volume of business under the tender.
- 15) The Managing Director of the Corporation reserves the right to amend or relax any of the tender terms.
