SHORT TERM TENDER FOR SUPPLY OF PACKING MATERIAL

The Karnataka Handloom Development Corporation Limited (A Government of Karnataka Enterprise), Bangalore invites tenders from actual manufacturers / authorised distributors of packing material as per the specifications are indicated at Annexure **"A", "B" and "C"**.

Following are the terms & conditions:-

1) METHOD OF SUBMISSION OF TENDER:-

(I) Tenders shall be submitted in two parts in two different sealed covers as under :-

a) **TECHNICAL BID:-**

Sealed cover containing status and technical details of the tenderer together with Earnest Money Deposit particulars. (Annexure **"B "**) **along with 3 metre sample in each variety compulsorily.**

b) **PRICE BID:-**

As per Annexure ' C '

1. **TECHNICAL BID – COVER 1 :-**

- a) To be submitted in sealed cover superscribed as "EARNEST MONEY DEPOSIT and TECHNICAL BID tender No.KHDC:M(Pur):MD:2009-10: 2127 dated 15.10.2009 for supply of Packing material due on 30.10.2009 and containing a Demand Draft for Rs.10,000/- in favour of `THE KARNATAKA HANDLOOM DEVELOPMENT CORPORATION LIMITED` payable at Bangalore.
- b) Earnest Money Deposit submitted by the tenderer/s will not carry any interest.
- c) Earnest Money Deposit of unsuccessful tenderer/s shall be returned within 30 days from the date of finalisation of tender.

- d) Earnest Money Deposit of the successful tenderer/s shall be returned by the Corporation only after satisfactory completion of the supplies in respect of the orders placed under this tender.
- e) Government Undertakings/Public Sector Undertakings and Cooperative Units are exempted from payment of Earnest Money Deposit.
- f) Technical bid shall be submitted in Annexure “**B**” on the tenderers letter head.
- g) In the Technical Bid, the cost of the packing material should not be indicated. The tenders shall be submitted in Kannada / English language only.

2 PRICE BID - (COVER-2) :-

- a) PRICE BID shall be submitted in sealed cover super scribed as “PRICE BID” for Short Term Tender No.KHDC:M(PUR):MD:2009-10/2127 Dated: 15.10.2009 for “ Supply of Packing Material” in the format (Annexure “**C**”) due on 30.10.2009.
- b) All the details in the format shall be filled and signed by the Tenderer (Each page should be signed with company /firm seal).
- c) The price bid should be accompanied by the supporting documents, if any.
- d) Tenderer shall indicate the duties & taxes wherever applicable. While indicating the excise duty if any, sales tax and percentage of taxes on the basic price shall be indicated failing which it will be presumed that the rates tendered are Nett, F.O.R. destination Banhatti, Jamkhandi Taluk, Bagalkot District and Peenya 2nd Stage, Bangalore, Karnataka State delivery and no claims on this account will be entertained at a future date.
- e) The tender will be considered only if submitted as indicated above.
- f) The **two** covers (TECHNICAL and PRICE BIDS) should be enclosed in a SEALED MASTER COVER superscribed as “TENDER FOR SUPPLY OF PACKING MATERIAL” addressed to the MANAGING DIRECTOR, The Karnataka Handloom Development Corporation Limited, No.1, Priyadarshini Commercial Complex, Tank Road, Halasur, Bangalore-560 042.

3 RECEIPT OF TENDERS:-

- a) Tender shall be received by the Corporation at its Bangalore Office upto 3.00 p.m on 30.10.2009 and tenders received after the due date and time will be summarily rejected. No telegraphic/fax tenders will be considered.
- b) No correspondence will be entertained once the tender has been submitted in response to the tender notice and no additional tender will be accepted.

4. OPENING & SELECTION OF TENDERS:-

- a) Tenders will be opened by the authorised officials of the Corporation in the presence of tenderers who choose to be present at 3.30 p.m. on 30.10.2009.
- b) The envelope carrying the Earnest Money Deposit [EMD] draft and Technical Bid of the tenderers who have submitted would be opened. Bids not accompanied by EMD even if opened are liable to be rejected. However, the right to accept/reject such tender/s will be at the discretionary powers of the Managing Director of the Corporation.
- c) Order will be placed on one or more tenderers considering quality, price and delivery schedule.

5. VALIDITY OF THE OFFER AND DELIVERY SCHEDULE:-

Offer shall be valid for a minimum period of 120 days from the date of opening the tender and rates tendered should be firm throughout the contract period i.e. execution of the purchase order in full as per the delivery schedule that will be indicated in the purchase order to be issued from time to time. Such delivery schedule may be postponed or preponed depending upon the requirement of our production units. No change in the terms of contract, as may be requested by the tenderers including rates shall be entertained during the tender contract period.

6 PAYMENT TERMS:-

Original bills along with supporting delivery notes, Excise Duty paid documents and other relevant documents shall be submitted to the Consignee alongwith the Consignment. Payment will be released within 30 days from the date of supply subject to acceptance of Quality.

TERMS OF SUPPLY AND PENALTIES:-

- a) Orders will be placed on one or more tenderers whose tenders are accepted at the discretion of the Corporation, subject to compliance with the terms & conditions.
- b) The Corporation shall have the right to recover any loss that it may sustain consequent to any breach on the part of the tenderer/s to fulfill the terms of contract including failure to supply partially or/in full/irregular supplies, out of the EMD amount.
- c) The successful tenderer is responsible for proper packing/transportation of packing material to our concerned destination in good condition at their own cost and risk.
- d) The KHDC Ltd., reserves the right to cancel the order with forfeiture of EMD if the supplies are not satisfactory as per the contract.
- e)** Payment terms shall be by 30 days interest free credit from the date of despatch of the material.
- f) No changes in the terms of contract as may be requested by the tenderer/s including rates shall be entertained during the tender contract period.
- g) Courts at Bangalore alone shall have the jurisdiction in case of any disputes arising between parties thereto either for the enforcement of the contract and or for any damages on account of breach of any of the terms of this agreement.
- h) The KHDC Limited reserves the right to accept/ negotiate / reject all or any part of the offer as well as decrease or increase the quantity of purchase order without assigning any reasons thereof. The KHDC Limited shall not give any guarantee regarding the volume of business under the tender.
